

INSTRUCTIONS

1. Mark only with a pencil having black lead.
2. To vote for any candidate whose name is printed on this ballot make a cross X mark in the voting space at the left of the name, or to vote a straight ticket for all candidates whose names are printed on this ballot within a group for a party position you may make a cross X mark within the circle below the title of the party position.
3. To vote for any person whose name is not printed on this ballot write the name of such person in the blank space provided for that purpose under the title of the public office or party position to which you wish him nominated or elected.
4. Any other mark than the cross X mark used for the purpose of voting, or any erasure, made on this ballot is unlawful.
5. If you tear or deface or wrongly mark this ballot, return it and obtain another.
