

His Excellency Mr. Kofi A. Annan, Secretary-General of the United Nations, United Nations Head Quarters, New York, United Sates of America.

Dear Secretary-General,

Thank you for your letter dated 12 February 2001 informing me of the High Level Intergovernmental Event on Financing for Development to be held in 2002.

As we agreed at the Millennium Summit, the problem of mobilising resources needed to finance development projects is an important issue that needs to be addressed urgently. As a small developing country, our ability to attract the necessary finance for our development is constrained by several limitations. It is my earnest hope that the Intergovernmental Event will have far-reaching implications for smaller countries like the Maldives in alleviating some of these constraints.

Considering the significance of the event to the Maldives, I can assure you of my full support and the co-operation of my government for the Conference. I have asked the relevant authorities of my government to keep in touch with the developments.
