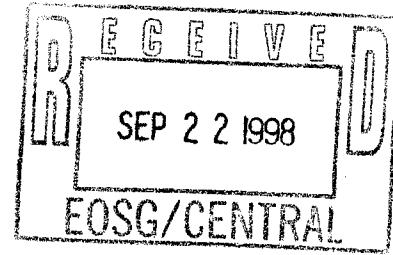

Dear Mr. President,

I have the honour to refer to my letter dated 8 July 1998 (document S/1998/640) by which, further to Paragraph 3 of Article 12 of the Statute of the International Tribunal for Rwanda, I forwarded to the Security Council the nominations for judges of the Trial Chambers of that Tribunal which had been received from States Members of the United Nations within the thirty-day period specified in Article 12 (3) (b) of its Statute.

I also have the honour to refer to the letter, dated 15 July 1998 (document S/1998/646), of the then President of the Security Council, Mr. Sergey V. Lavrov, in which he informed me of the decision of the Security Council which was taken at its 3908th meeting on 15 July 1998 to agree to the suggestion which I had made in my letter of 8 July 1998 that the Council extend the deadline for nominations for judges of the Trial Chambers of the International Tribunal for Rwanda until 4 August 1998.

I have the honour moreover to refer to my letter dated 7 August 1998 by which I forwarded to the Security Council the nominations for judges of the Trial Chambers of the International Tribunal for Rwanda which had been received from States Members of the United Nations within the thirty-day period specified in Article 12 (3) (b) of its Statute, as extended by the decision taken by the Security Council at its 3908th meeting.

I have the honour furthermore to refer to the letter, dated 18 August 1998 (document S/1998/761), of the former President of the Security Council, Dr. Danilo Türk, in which he informed me of the decision of the Security Council which was taken at its 3917th meeting on 18 August 1998 further to extend the deadline for nominations for judges of the Trial Chambers of the International Tribunal for Rwanda until 14 September 1998.

Pursuant to Paragraph 3 (c) of the Statute of the International Tribunal for Rwanda, I have the honour now to forward to the Security Council the nominations for judges of the Trial Chambers of the Tribunal which have been received from States Members of the United Nations within the period specified in Paragraph 3 (b) of Article 12 of that Statute, as extended by the Security Council in the decision taken at its 3908th meeting and as further extended by the Council in the decision taken at its 3917th meeting. The list of candidates, in alphabetical order, is annexed to this letter, together with the curricula vitae which have been provided in connection with their nominations.

I would draw the attention of the Security Council in this regard to paragraph 3 (c) of Article 12 of the Tribunal's Statute, which provides in relevant part as follows: "From the nominations received, the Security Council shall establish a list of not less than eighteen and not more than twenty-seven candidates, taking due account of the adequate representation on the International Tribunal for Rwanda of the principal legal systems of the world".

Please accept, Mr. President, the assurances of my highest consideration.
