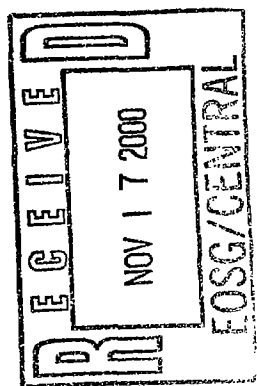

(to Mr. Prendergast)

1. As you are aware, the Secretary-General has decided to send Mr. Lakhdar Brahimi on a special mission to Cote d'Ivoire with respect to the situation in that country. In this connection, Mr. Brahimi will travel to Abidjan to hold meetings with Ivorian authorities and come to New York to report to the Secretary-General. It is my understanding that Mr. Brahimi intends to undertake this mission from 21 – 25 November and is expected to come to New York around the 27th. It is also my understanding that the Secretary-General, Mr. Brahimi and yourself had a general discussion on the terms of reference for Mr. Brahimi.

2. In the light of the above, may I request DPA (in backstopping Mr. Brahimi's mission) to undertake the following:

- a. Identify a staff member from DPA to accompany Mr. Brahimi, *John Brown*
- b. Make arrangements for the issuance of tickets to Mr. Brahimi and his assistant. Mr. Brahimi requested the following travel itinerary: Paris/Abidjan/Paris/New York/Paris. Precise dates should be coordinated with him.
- c. Inform urgently the Resident Coordinator in Abidjan regarding Mr. Brahimi's visit.
- d. Request the Permanent Mission of Cote d'Ivoire here in New York to inform the Ivorian Embassy and/or Consulate in Paris about Mr. Brahimi's visit and request that the issuance of required visas be facilitated. The assistance of UNIC/Paris may be sought in this regard.
