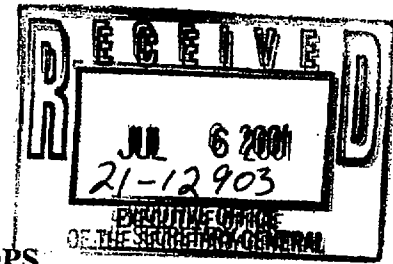

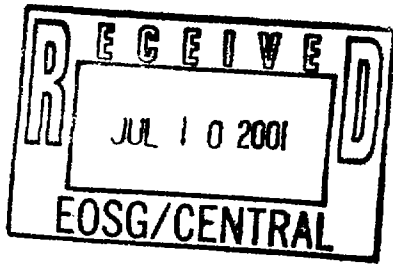

Excellency,

Thank you for your letter of 22 June informing me of the very generous offer of the Government of Japan to support the Office for the Coordination of Humanitarian Affairs in its activities to alleviate the suffering of internally displaced persons, for which I am particularly grateful.

As you are aware, the plight of the world's internally displaced has been a matter of great concern to me. As a result, I have recently endorsed the recommendations of the Under-Secretary-General for Humanitarian Affairs and Emergency Relief Coordinator as to how the United Nations may better address and respond to their needs. These included the establishment of an Internally Displaced Persons Unit within the Office for the Coordination of Humanitarian Affairs which your Government has so kindly and so swiftly agreed to support.

I am greatly heartened by your generosity and very much welcome your commitment to ensuring the success of the new Unit and the ongoing advocacy efforts of my Representative on Internally Displaced Persons, Mr. Francis Deng.
