



LE SECRÉTAIRE GÉNÉRAL

Monsieur l'Ambassadeur,

Je vous remercie de votre participation à la réunion du 13 août 2004, organisée par M. Prendergast, Secrétaire général adjoint aux affaires politiques, à l'intention des contribuants financiers potentiels en vue de la création d'une entité distincte sous le commandement unifié de la force multinationale avec pour seule mission d'assurer la sécurité de la présence des Nations Unies en Iraq, conformément à la résolution 1546 (2004) du Conseil de sécurité, en date du 8 juin 2004.

Comme vous le savez, la résolution 1546 (2004) tient compte du fait que l'application de mesures visant à assurer la sécurité du personnel des organismes des Nations Unies travaillant en Iraq nécessiterait des ressources importantes, et demande aux États Membres et aux organisations concernées de fournir ces ressources, notamment en versant des contributions pour le financement de l'entité spécialement chargée de la protection, que l'on envisage de créer sous le commandement de la force multinationale.

Bien qu'elle tienne son mandat du Conseil de sécurité, la force multinationale n'est pas constituée en opération des Nations Unies. Par conséquent, l'ONU ne joue aucun rôle dans son financement, son déploiement, le commandement sur le terrain ou l'appui aux opérations. Nous ne ménageons aucun effort pour assurer des conditions satisfaisantes au déploiement de notre personnel en Iraq, mais il incombe principalement à la force multinationale d'assurer la sécurité du personnel de l'ONU, grâce, notamment, à la création d'une entité spécialement chargée de la protection. Je vous assure que l'Organisation affirme sans réserve les efforts de la force multinationale dans ce domaine.

Au moment où l'ONU rétablit sa présence internationale en Iraq et y reprend son rôle international, il est essentiel qu'une composante distincte de la force multinationale, ayant pour seule mission la protection de l'Organisation, soit dotée des effectifs militaires et des ressources financières qui lui permettront d'instaurer des conditions de sécurité satisfaisantes, avec le concours du Gouvernement iraquien. La présence d'une force dotée d'un effectif et de ressources adéquats contribuera à rendre possible le retour en Iraq du personnel des Nations Unies afin d'exécuter les tâches prescrites par le Conseil de sécurité. C'est pourquoi je demande instamment à votre gouvernement d'apporter à cette force une contribution sous quelque forme que ce soit.
