



**Note to the Secretary-General**

**Working Group on DPKO-World Bank strategic cooperation**

1. During my meeting of 28 March with then World Bank President, James Wolfensohn, we agreed to initiate a short-term working group to develop proposals for strategic areas of future cooperation between DPKO and the World Bank. We proposed that this group would report back after 90 days with concrete ideas for developing strategic cooperation.
2. DPKO's Peacekeeping Best Practices Section led the UN effort in this working group which involved a series of exchanges between DPKO and the World Bank on thematic issues as well as discussions on specific post-conflict countries. DPKO's UN partners (UNDP/BCPR, UNDG, DPA, OCHA and EOSG) were incorporated into discussions on coordination challenges of our different planning processes (CAP, PCNA, DPKO mission planning). The process concluded with a very successful exchange of high level briefings to senior staff in DPKO and the World Bank.
3. There is clear recognition on both sides of the importance of DPKO-WB partnership in post-conflict countries, a shared sense of objectives and acknowledgement that political, security and economic reconstruction must be addressed in an integrated manner. At the same time, the working group identified gaps in our knowledge of each other's respective processes and instruments. These gaps impede operational cooperation on issues of mutual concern, particularly economic governance issues, customs and transit and natural resource management.
4. We have therefore agreed to continue to develop DPKO-WB strategic cooperation focusing on four areas: a) exchange discussions on our respective instruments in relation to post-conflict economic governance (Security Council processes, WB budget support operations and public finance management reviews); b) six-monthly exchanges on post-conflict operations, with particular focus on Africa; c) provision of induction training/briefing to senior staff including the possible participation of World Bank staff in DPKO senior management training courses; and d) joint research projects. One of these, a mapping exercise of relations between senior mission management and the Bank in the field, is already underway.
5. In the context of wider UN-World Bank cooperation, coordination of our respective planning processes is an area in which we hope to move forward. This effort could usefully be incorporated in the proposed DPKO-led inter-agency review of the Integrated Missions Planning Process (IMPP). I hope to explore this issue shortly with the new head of UNDP, Mr. Dervis. Another area identified is a joint review of current staff exchanges between the World Bank and the UN system.



6. Important as these strategic processes are, I believe that, ultimately, operational cooperation will be the engine that drives forward DPKO's partnership with the World Bank. For this reason, it is crucial that we continue to explore the specific cases of Liberia and DRC, where our two organizations must spearhead larger international efforts to address economic governance issues in post-conflict transitional governments. Without progress in this area, the best security provisions in the world will fail to bring about definitive peace.

7. During my initial visit to Washington in March I met with Mr. Wolfowitz. As the new World Bank President settles in to his new position, I will, with your concurrence, solicit his support for the continued development of our strategic partnership and keep you apprised of our progress.

BTW - one thing that the SG should be aware of, is that the World Bank generated idea for more active DPKO/mission roles, in collaboration with them, to develop natural resources management mechanisms, while operationally sound, are creating some blow back for us within the GA process on the peacebuilding commission. Concerns that the UNSC is stretching its mandate into eco/soc areas. Of course, we've done this stuff before both in Kosovo and East Timor under executive authority mandates. But SG should be aware of the broader politics as this moves forward. I'll also raise with DPKO. B
