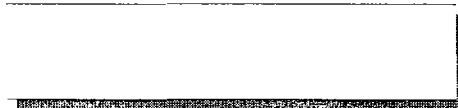

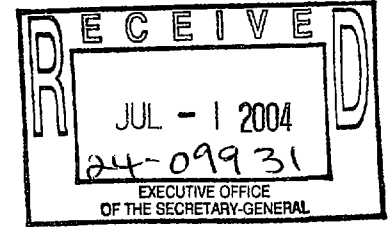

We are most anxious that the momentum created by your announcements should not be lost, and we urge you to give consideration to announcing the appointment of a suitable person for the post in the very near future.

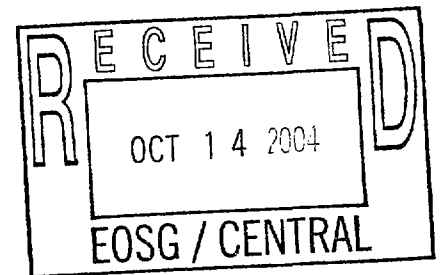

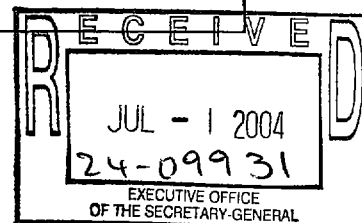
