It is now five months since we had the privilege of hearing you announce at the Stockholm International Forum on Preventing Genocide that consideration should be given to creating the position of Special Advisor on Genocide Prevention at the United Nations. Since then, you have announced that you will appoint the Special Advisor, most notably in your momentous address on the prevention of genocide delivered to the Commission on Human Rights in Geneva on 7 April 2004.

We are most anxious that the momentum created by your announcements should not be lost, and we urge you to give consideration to announcing the appointment of a suitable person for the post in the very near future.

We were most grateful for the gracious letter sent to us by Assistant-Secretary-General for Political Affairs Danilo Turk on 7 April thanking the International Campaign to End Genocide for our work.

We thank you for your leadership in taking this important step to advance the vital work of the United Nations in preventing genocide.
