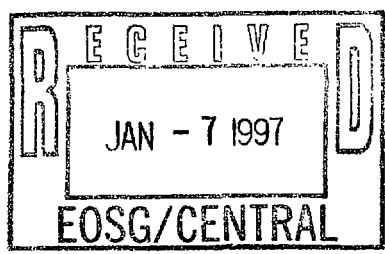

Note to the Secretary-General

1. At the informal consultations this morning, the Security Council members agreed on a provisional Programme of Work for the month of January 1997. A copy is enclosed.

2. The President (Ambassador Owada of Japan) briefed members about his meeting with you on 2 January.

3. The Council will have informal consultations on the situation in the Great Lakes region on Wednesday, 8 January. Members have requested a briefing from the Secretariat, including also the situation in Burundi. You might wish to ask Mr. Goulding to do the briefing.

4. Following informal consultations, the Council met successively in Conference Room 7 as Sanctions Committees and elected their Bureaux for 1997. The composition of the Bureaux is enclosed.

5. The President also circulated a note, copy enclosed, on how he would like the Council to conduct its work. Ambassador Fulci, during his Presidency in December 1996, started the meetings on time, irrespective of how many members were present in the room. Since then, members have got used to being punctual.

JANUARY 1997 (JAPANESE PRESIDENCY)
NOTES ON THE CONDUCT OF BUSINESS

As president of the Security Council for the month of January, I propose to work on the basis of the following assumptions:

1. The expressions of congratulations to new members and the President, and tributes to the outgoing members, should be dispensed with in both informal and formal meetings. On behalf of all the members of the Council, the President will express thanks to the outgoing President.
2. Meetings in principle will begin on time as scheduled. Consultations of the whole will be scheduled for 10:30 a.m. and/or 3:30 p.m. The President will be in his office at least 15 minutes before the beginning of consultations.
3. The conduct of informal consultations of the whole should be as informal as possible. Members are encouraged to refrain from making comprehensive policy statements in informals.
4. We should try to schedule consultations and meetings, where possible avoiding Mondays and Fridays.
5. The practice of having the representative of the Secretariat announce what items he or she wishes to raise under "other matters" at the beginning of the consultations will be continued.
6. The distribution of maps by the Secretariat will also be continued.
7. Other practical steps that have been taken by the Council in the past to enhance its working efficiency will be followed as appropriate.
