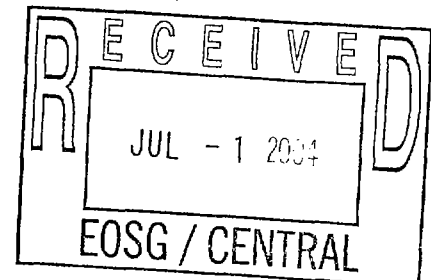

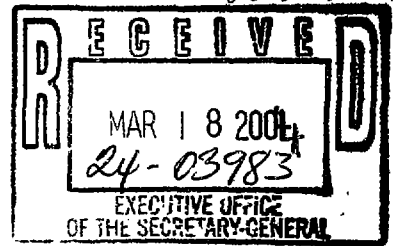

May I also inform you that the Panel intends to invite Mr. Mohamed ElBaradei to attend one of its sessions during its fourth meeting at Baden.

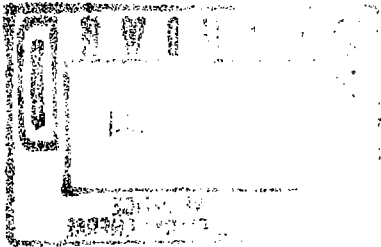
