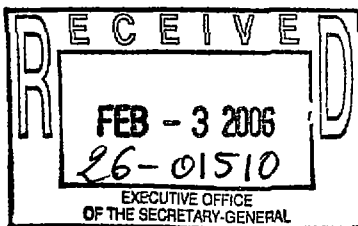

I have the honor to refer to your note dated the 30<sup>th</sup> of December 2005, concerning my Governments assessed contribution to the regular budget of the United Nations for the year 2006. 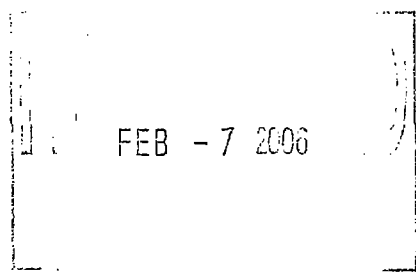
We would highly appreciate your kind consideration of this request that would enable us to meet our financial obligations towards the United Nations for the year 2006.

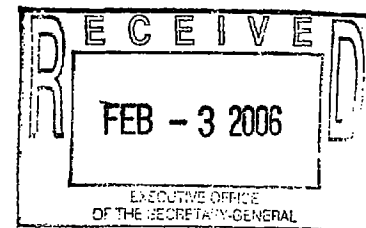
